# Become a Danube.Pearl!

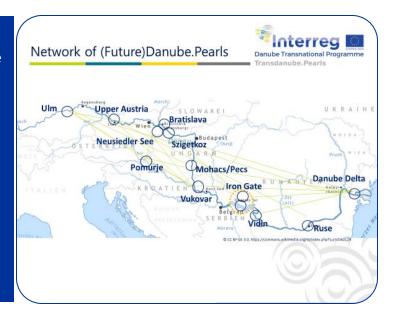
#### **Preconditions**

## Danube.Pearl Common Standards

define the level of service a visitor can expect when visiting a Danube.Pearl. These standards are divided into two parts.

#### **Basic Requirements**

- Management & Strategy & Commitment
- Tourism specific criteria
- Criteria for mobility services
- Communication/Marketing (sustainable touristic stakeholders & products)

#### **Additional requirements**

- Mobility services for tourists
- Mobility of day visitors
- Mobility of residents & tourists
- Special Danube mobility services to support "Danube experiences with sustainable transport"

The Basic Requirements have to be met to become a member of the network.

The common standards support the development of new mobility services and the improvement of links between existing modes of transport. This contributes to sustainable regional and local mobility but also supports the connectivity between the regions, leading to a more balanced accessibility within the Danube regions

Besides the common standards act as a guideline for destinations on how to become more sustainable in terms of a socially fair, economically viable, environmental friendly and health promoting mobility and tourism for visitors as well as for inhabitants.







## A Danube.Pearl...

- participates actively in the network activities
- participates in Danube.Pearls meetings, exchanges experience and know-how
- meets common standards and checks them regularly
- assures continuity > one contact person for network management
- secures the sustainable operation of the network (by drawing up a business plan, paying membership fees, active participation, fund-raising, etc.)
- improves the mobility services for costumers (citizens and guests) currently
- coordinates local coalition with service providers
   Coordination and cooperation with stakeholders and local service providers is crucial to offer tourism products with sustainable mobility and to inform the visitors in the best possible way!
- trains local staff (tour guides/operators and hospitality) to inform about sustainable mobility (by organising peer group exchange, train the trainer concept etc.)
- informs visitors about adequate sustainable mobility
- sustains and improves visitor management > trains employees in the guest information points (visitor centers, hotels, train station etc.)
- develops products on transnational and Danube.Pearls' level
