## **MAIN ACTIVITIES**

- Dialogue workshops focusing on relevant regional, national and macro regional but also EU level policy fields involving also end-users of RIs;
- Special trainings for defined target groups, thus contributing to capacity building with an outreach to the entire macro-region and beyond the involved partnership;
- Collection of a dataset of qualified reviewers for RI assessments;
- Two pilot activities focusing on (I) peer reviews of nine existing RIs and (2) Ex ante assessments of three planned RIs in the Danube macro region;
- Dedicated dissemination and capitalisation actions contribute to the policy take up and utilisation of the results.
