Background

OP (operational plan) is a basis for multi-use management in urban forests. OP includes elements of tactical and operational plan. The framework for it is a strategic plan for integrated multi-use forest management for the whole area of urban forests of certain urban centres. The perimeter of OP is a rounded area within a wider area of urban forests. OP is the basis for the implementation of the activities and measures in urban forest for providing desired ecosystem services. Additional detailed operational plans (projects, sketches) for carrying out the activities and measures defined in OP can be elaborated.

Writing style, maps, appendix

The OP is a tool for communication with various stakeholders, therefore a relatively short and understanding text in all sections of the plan is desired. The main text should contain crucial information and decisions about integrated management in urban forests in the next planning period; simple tables and understandable maps are desired. All additional information (text, tables, maps) relevant for the understanding of the main text of OP should be included in the appendix.

Participation of stakeholders

In the planning process, a participation of stakeholders is foreseen. The participation is important part of the planning process, even more important than writing the text only. Therefore, a big effort should be made to include stakeholders in the planning process.

Availability of data, legal conditions

A plan is going to be used in various conditions with different availability of data related to the forests and the management in your study area. Main effort focuses on planning and decisions on management in the next period and not on collecting the data.

Planning system

The content of OP is in accordance with the strategic plan and legal documents relevant for the individual study area.

1 INTRODUCTION

1.1 The aim and purpose of OP

• The aim of OP

To restore "the current image" of UF and to make sure that urban forest (UF) area becomes place for socialization, relaxation, recreation, education, high quality experiencing of natural heritage and greentourism for a diverse set of target groups.

• The purpose of the plan

OP is a basic document for the Ivano-Frankivsk city for forest management; it is the basis for the participation of the forestry administration, city administration and stakeholders in the management of the UPF.

 Link to the strategic part of integrated multi-use management plan The OPUF correlates to the aim of the Strategic part of the Integrated Multifunctional Management Plan (IMMP) that is to identify demands towards urban and peri-urban forests (UPF) in Ivano-Frankivsk, potential conflicts between different forest users, to define strategic long-term management objectives in UPF, and to define priorities amongst management objectives and ecosystem service (ES). The strategic part also defines management guidelines that represent the basis for the definition of operational goals and measures. Moreover, OPUF matches the strategic priorities: preserve nature on the strategic area; ensure safety and coexisting of all users and ensure multifunctional use of area.

1.2 The design of the plan, obligations and validity of OP

Basis for OP

Following legal documents were the bases for the framework for the planning process:

- The Constitution of Ukraine,
- The Forest Code of Ukraine
- The Land Code of Ukraine
- The relevant laws of Ukraine
- The regulations on state forest protection
- On the Nature Reserve Fund of Ukraine
- The relevant provisions and guidelines for forestry
- The local and regional orders

 Relation to forest management and other planning bases OP is a basis for the preparation of spatial plans for the UPF area that will be used by the State Enterprise "Ivano-Frankivsk state forestry".

Obligation

- OP is binding for SE "Ivano-Frankivsk state forestry", Executive Committee of Ivano-Frankivsk City Council and Vovchynets village council.
- OP is a mandatory basis for the Ivano-Frankivsk city administration, the planning of the use of funds, and for the acquisition of international or national projects that are in line with the content of the OP.
- OP is the basis for the participation of the Ivano-Frankivsk State Regional Administration in the preparation of Forest Management Plans. Thus, OP directly and indirectly influences the work of the forestry administration, which is generally responsible for forest planning, management and monitoring.
- Guidelines defined by OP are not directly binding for forest related business; however, the OP is an instrument for the communication with private owners about forest management, and a basis for projects/agreements. Some limitation for forest management can derive from the importance of forest for societal functions OR/AND from the legal regulations if the UPF area was declared by state or municipality as a forest category with a specific value/treatment.
- Preparation of the plan

Both Executive Committee of Ivano-Frankivsk City Council and SE "Ivano-Frankivsk state forestry" are responsible for preparing the plan with the active participation of Vovchynets village council. The main content is being prepared by the Executive Committee of Ivano-Frankivsk City Council (coordinated by the project team) based on the data received from forestry managers and village council representatives. However, plan will be finalized only after approval from SE "Ivano-Frankivsk Forestry" and Vovchynets village council. Communication between the forestry administration and the city administration is extremely important during the OP preparation.

Time validity

The timeframe of the OPUF is 10 years (2020 – 2030). The plan will be checked and updated if needed each 2 years. Both Executive Committee of Ivano-Frankivsk City Council and SE "Ivano-Frankivsk Forestry" are responsible for the plan revision.

 Implementation and operational planning OP is the basis for the implementation of the activities of the city administration in the UPF area. It includes guidelines, planned measures and facilities. OP cannot contain all the details for the implementation; therefore, activities that are defined in the OP can be elaborated during the period of validity of OP in detail by operational projects (even after the end of URBforDAN project).

OP area

Strategic area in Ivano-Frankivsk has a surface of 580.39 ha and includes part of Kozakova Valley and Vovchynets Hill (see Figure 1). The State Enterprise "Ivano-Frankivsk Forestry" manages the area.

Kozakova Valley is a landscape reserve of national importance in Ukraine. It is located in the Tysmenytsia district of Ivano-Frankivsk region, north of Ivano-Frankivsk, and south of Ezupiul village. Surface of all area of Reserve is- 953 hectares. Created in 1982. The status is separate outcrops of limestone rocks and small karst caves. The forest occupies 100% of total area.

The Vovchynets Hill occupies an area of 20 hectares and is given to preserve the picturesque tract on the right bank of Bystrytsia river, dissected by deep beams, with the focus area of project (Figure 1. The peri-urban forest occupies 75.5% of the total area of the hill (15.1 hectares). The area is not protected, but the Hill is a natural monument of local importance.

2 THE IMPORTANCE OF URBAN FORESTS AND MAIN MANAGEMENT OBJECTIVES

2.1 Purpose of UPF

 Ecosystem services/ forest functions/ importance of UPF The main ecosystem services that were found relevant with the 1st and the 2nd rank of importance are:

- o Provisioning ES
- Regulating ES
- Supporting ES
- o Cultural ES
- ➤ Provisioning ES: Non-timber products. There are places for gathering of mushrooms, medicinal herbs collection on the focus area, but for personal use only. In this case, it's important rank of ES importance.
- Regulating ES: Local air quality. Forest protects settlements from pollution due to its proximity to major city road, village's roads and factories / companies producing products. Accordingly, rank is very important.
- ➤ Supporting ES: Nature protection / habitats for species. The vegetation covers about 300 species. Oak-beech virgin forest with rich undergrowth and grass cover grows on wet soils. In addition, rocky oak, as an admixture a European larch (Larix decidua), elm tree (Ulmus glabra) grow there. Among the herbs, several species are listed in the Red Book of Ukraine: snowdrop (Galanthus nivalis), terrestrial orchid (Neottia ovata), and crocus (Crocus sativus). As for animal world, there are roe deer (Capreolus capreolus), boar (Sus scrofa), forest marten (European pine marten), gray hare (Lepus europaeus), badger (Meles meles), least weasel (Mustela nivalis), etc. Such rich flora and fauna means very important rank for the area.
- ➤ Cultural ES: Recreation and tourism. Multiple use of trails (cycling, walking, horse riding, skiing, ATVs riding, motorcycling), panoramic trails, tourist routes to the Landscape Reserve are common for the focus area. The shown biggest cycling route has the length of nearly 25 km and can be one of tourist attraction due to its significant sightseeing points, historical and cultural values (there some nice legends and mysteries stories that can be interesting for the potential tourists).
- ➤ Cultural ES: Cultural heritage. Landscape Reserve of the national value "Kozakova Valley" and the complex nature monument of local importance "Vovchynets Hill" have historical and cultural value.

Target groups / users

- The main groups:
- local population; different groups of visitors engaged in recreation
- o tourists
- o educational institutions
- forest owners

The City of Ivano-Frankivsk identified 18 stakeholder groups of users of the Vovchynets hill (see Figure 2).

However only the following ones were selected as Key Stakeholders based on the conducted survey¹ within URBforDAN project:

- Hikers
- Cyclists
- Downhill Cyclists
- Joggers
- Pet Walkers
- Collectors of non-timber forest resources
- Families with children

3 STATE OF FORESTS AND FOREST USE

3.1 State of forests and forest management

Forest area

Strategic area in Ivano-Frankivsk has a surface of 580.39 ha and includes part of Kozakova Valley and Vovchynets

Kozakova Valley - the forest occupies 100% of total area. The Vovchynets Hill occupies an area of 20 hectares and is the focus area of project. The peri-urban forest occupies 75.5% of the total area of the hill (15.1 hectares).

• Ownership of forests

The State Enterprise "Ivano-Frankivsk Forestry" manages the area. 100% public – state property.

 Forests, site conditions, forest types, stand types The forests of the State Enterprise «Ivano-Frankivsk Forestry» mainly perform protective, ecological and recreational functions and have some operational significance. With an average annual growth per 1 ha of forest covered area of 3.8 m3, the size of forest use in the whole area is 34-35 thousand m3, which is about 40 percent of annual growth. The peri-urban forest occupies 75.5% of the total area of the Vovchynets Hill (15.1 hectares).

The average age of forest plantations in the forestry is 59 years, the average stock of wood per 1 ha of forested area is 197 m3, the average annual growth is -3.8 m3/ha, The average fullness is 0.72, and the average bonus is 1.8.

The estimated logging of the main use is 20 thousand m3, including the stud farm - 5.47 thousand m3, hardwood - 10.5 thousand m3, softwood 4.03 thousand m3.

Forest operations

Forest on the focus area is used mainly for recreation of users. Forest operations includes planting trees, carrying out reforestation, carrying out forest health restoration measures, carting out erosion control; measures, fire hazard reduction measures.

Wood production

Not used, not allowed on the Reserve area

Forest accessibility

There are forests road and skidding trails but not in good condition. For more than 10 years, they were not improved.

Impacts, problems

Damage from human activities, destruction of limestone rocks, corrosion from rain

3.2 Visit to UPF and infrastructure

Visit to forest

There is no statistic of number of the visitors of the area. The structure of visitors:

- residents of adjoining area (settlements near the forests)
- cvclists
- families
- young couples

Mainly conflicts regarding the visit of the UPF are between downhill cyclists, extreme automobile racers and people living nearby the Hill. Extremals scary people and make them feel unsafe during their ridings. People living nearby the Vovchynets Hill mentioned that auto or moto riders are noisy; they polluted air and behave not appropriately.

 Already available infrastructure

Accessibility

There is a bus stop in the entrance in the Vovchynets village. Buses go from city centre (route no.34).

One of the major city roads ends near the entrance to the Vovchynets Hill (Vovchynetska Street).

length of routes




Figure 3 - Cycling route

The shown biggest cycling route (see Figure 3) has the length of nearly 25 km and can be one of tourist attraction due to its significant sightseeing points, historical and cultural values (there some nice legends and mysteries stories that can be interesting for the potential tourists).

cycling polygons

Downhill cyclists made up to 5 special tracks in the forest.

Fireplaces

There are no any special designed fireplaces in the area. Only places used by visitors as a fireplace.

Viewpoints

A few panoramic spaces are located on the area but not equipped now.

Benches

There are no benches on the area.

o springs / water

There is one spring on the area of Reserve but it is not suitable for the drinking as it is much polluted.

3.3 Important objects in UPF

Nature conservation

Kozakova Valley is a landscape reserve of national importance in Ukraine.

The Vovchynets Hill is a natural monument of local importance.

Cultural heritage

Landscape Reserve of the national value "Kozakova Valley" and the complex nature monument of local importance "Vovchynets Hill" have historical and cultural value.

On the focus area there are (see Figure 4):

1 rock

1 cross of the Ukrainian Insurgent Army

As Strategic part of forest area includes protected areas, the recreational pressure goes on focus area. Moreover, because focus area located on the Vovchynets Hill, there is a great panoramic view that attracts visitors (Gypsum stones from Vovchynets Hill served as construction material for building the foundations of many houses of the city of Stanislavov (now Ivano-Frankivsk). This proves the importance of the Cultural ES in UPF.

3.4 Assessment of use, changes and influencing factors

Damages, risks

The main damages to forests come from climate changes and impact of users.

The potential threats to forests are constructions; concerts; car racing and other measures that destroy nature and which involve a large number of people at one point.

Issues of forest use

The significant issues of the forest use are:

- ✓ Absence of equipped places for rest
- ✓ Absence of proper road infrastructure
- ✓ Accumulation of MSW, low level of information about important events
- ✓ Arrival by cars
- ✓ Broken branches of trees
- ✓ Construction, bad road
- ✓ Difficulties with getting to the top of the hill
- ✓ Driving by car to the top
- Frequently cars travel and in warm weather raise smoking and dust that makes impossible to breathe.
- ✓ Indifference of people to the environment.
- ✓ Irresponsible attitude of visitors to the Vovchynets Hill
- ✓ Lack of well-equipped zones, areas for comfortable rest, toilets, shops, cafes, children's areas, sports grounds
- ✓ No cycling and pedestrian paths, lighting, no playground for children,
- ✓ Road erosion
- ✓ Lack of strategic plan for development and regulation, security in the territory (human). Protection of territory from illegal buildings, infrastructure.
- ✓ Territory degradation, ineffective use of the territory's potential
- ✓ There are no tracks, places for rest (benches, pavilions), observation areas
- ✓ There is no proper road infrastructure
- ✓ There is no proper safe entrance and drainage from the carriageway. There is no fencing on the side of the gorges. There is no organized collection of garbage (points with garbage bins and their removal).
- ✓ There is no recreational infrastructure, the territory should be zoned for recreation, scientific and economic activity
- ✓ There is no zoning of territory, there is no convenient pedestrian and bicycle infrastructure, lack of lighting, street furniture, urns and various kinds of attractions.

4 GUIDELINES FOR FOREST MANAGEMENT

4.1 **Subordinated guidelines**

Forest management plans

Spatial plans

• Strategic plan for UPF

The main goal of Forest management plan is area protection. It will not be used for harvesting, wood production in next 10 years.

Spatial plan foresees zoning of most popular activities on the area:

- Cycling zone and routes
- Kids playgrounds and education zone
- Observation deck
- Parking zone
- Walking routes and recreational zones (picnics, toilets)
- Sport zones (motor transport zone, horse riding etc.).

Main Spatial development strategy objectives are the multifunctional use of area, coexisting and safety of all users, nature protection. The space has to be developed based on this objectives and human values (people-centred approach). Specifically, the area should become more accessible year by year for all especially people with disabilities, retired people.

Strategic part of the OPUF is planned for 10 years and based on current laws, regulations and regional/local programmes. As city borders will be wider regarding decentralization reform in Ukraine, urban forest will become more popular spot for recreational and its ES service will play more crucial role for settlement. Moreover, this means that protection nature measures should be strict and systematic. The main risks are increase of area load by visitors, interest of developers to build houses or commercial entities.

4.2 Fundamental/basic concepts

• Forest land, forest area

The peri-urban forest occupies 75.5% of the total area of the Vovchynets Hill (15.1 hectares) and won't be enlarged. The State Enterprise "Ivano-Frankivsk Forestry" will continue to maintain the forest in similar condition..

Structure and forest composition

We plan to intensive only forest care. Care includes a set of agronomic and forestry measures aimed at improving the conditions of survival and growth of forest crops. This includes improving the quality of the soil, removing grass and unwanted woody vegetation, and enriching the soil with nutrients. Also we

will try to plant a range of decorative trees - red-leaves mapleson the observation deck areas AS focus area is highly used for recreation and is closed to the settlements — plan foresees only its maintain.

 Technology of wood production Forestry does not product wood on the focus area.

Nature conservation

The conservation and protection of forests is carried out through comprehensive measures aimed at protecting them from fires, illegal logging, damage and other influence, protection against pests and diseases.

The threat of forest fires is growing due to the increase in the number of visitors for the purpose of relaxation, kindling. Therefore, to effectively protect it from forest fires, active preventive work is carried out among the population and young people, and in case of fire or fire - extinguishing according to the developed and approved mobilization plans for their elimination. Systematic monitoring of their condition, timely detection of pests and diseases, implementation of prevention of their occurrence, their localization and elimination, ensures the protection of forests from pests and diseases.

Biological and forestry methods are used to control pests and diseases: sanitary felling, pruning care, deforestation and forest clearing, hanging of pheromone traps, protection and resettlement of ants, production and hanging of artificial nests.

 Areas with emphasized ES (or forest functions) in the UPF area Additionally, four more ES services will be promoted within the project. Consequently, project activities includes improvement of focus area by installing equipment:

- o Classroom in nature with forest playground and nature campsite for children (Scientific / educational).
- o Equipment for parking and a viewing-point platform
- o Equipment for recreational zone for cycling community
- o Information and education plates for visitors with markings for walking paths and cycling trails
- o Tables with benches

• The use of forests

This peri-urban forest territory, also known as Vovchynets Hills, is the most attractive natural environment (heritage) for the weekend rest. It will attract more visitors of all ages. The visitors will use it for cycling, walking, spending family time, education. Also the area could be used for the purpose of bike competitions, developing new sport activities

• Infrastructure in the forest area

Focus area infrastructure is not developed right now. There is a bus stop in the entrance in the Vovchynets village. Buses go from city centre (route no.34). One of the major city roads ends near the entrance to the Vovchynets Hill (Vovchynetska Street).

A few panoramic spaces are located on the area but not equipped now It is just being maintained and preserved from the threats. Because of the lime stock ground — the road, trails are usually damaged quickly. In this term, forestry, village and city councils have to find out new technologies or materials for appropriate cover. Other important issues are the need of properly arranged parking lots, toilets, info points, better entrance, marking of routes.

 Communication / Informing the public Executive Committee of Ivano-Frankivsk City Council will organize a Public presentation of the final draft of the IMMP. Strategic and Operational parts will be presented not only to forest managers, but also to all interested public - it will be invited to comment final draft documents and deliver suggestions for their improvement. Public will be informed through: public events, Facebook post, media publications.

Executive Committee of Ivano-Frankivsk City Council will review the comments and will consider them in preparation of final versions of IMMP. Executive Committee of Ivano-Frankivsk City Council will monitor the changes and the implementation of activities in UPF together with Sate Forestry and Vovchynets Village council. Executive Committee of Ivano-Frankivsk City Council (Investment Policy Department) is responsible for informing the public.

 Cooperation between stakeholders Cooperation has started from the project proposal preparation and continues now. Vovchynets village council initiated the project on road construction with observation decks and parking places. While designing the project, Executive Committee of Ivano-Frankivsk City Council offered the cooperation within joint project. At this moment Executive Committee of Ivano-Frankivsk City Council discuss the project idea with the SE "Ivano-Frankivsk Forestry" and received positive feedback. From that discussion, all events and activities (phase of ES assessment, elaborating of specific objectives for the IMMP, OPUF) were conducted through close and active participation of each institutions.

4.3 Guidelines for allocations with priority ES

Allocations for priority ES




Figure 5 – ES services for the focus area

The main ecosystem services are (see Figure 5):

- Regulating ES
- Cultural ES

Regulating ES: Local air quality. Forest protects settlements from pollution due to its proximity to major city road, village's roads and factories / companies producing products.

Cultural ES: Recreation and tourism. Multiple use of trails (cycling, walking, horse riding, skiing, ATVs riding, motorcycling), panoramic trails, tourist routes are common for the focus area. Cultural ES: Cultural heritage. The complex nature monument of local importance "Vovchynets Hill" has historical and cultural value.

Other multifunctional forests

Forests provide a large range of other products, such as cork, resins, mushrooms, nuts, game or berries as well as recreational services, which are increasingly being valued on the market. Promoting new value chains for such products can be a powerful economic incentive for integrated forest management schemes, increasing forest multifunctionality, contributing to sustainable forest management and fostering rural development².

Overlapping of allocations

Focus area is small but still several ES service are ensured. The priority ES services (Non-timber products, Local air quality, Recreation and tourism, Scientific / educational and Cultural heritage) overlap with ES without high importance (Timber production, Local climate mitigation and Protection against noise pollution). Such a mix of ES service opens more opportunities for multifunctional area development.




Figure 6 - Zoning regarding the forest land use of the strategic and forest areas

Reforestation works are planned so that the stands with the best principal tree species would grow on the site with optimum costs within the shortest period of time in the new forest generation. In the process of reforestation the natural reforestation of different existing tree species and old crop trees, down timber and broad-leaved hardwood contributing to the biological diversity are tried to retain as much as possible.




Figure 7 - Possible entries to the focus area

There is a bus stop in the entrance in the Vovchynets village. Buses go from city centre (route no.34).

In 10 years the arrangement of other entries can be revised due to the decentralisation process and urbanisation.

Condition — it's not well-arranged, there is no any parking space, bike parking lots, barriers. There are some informational boards about behaviour in the forest, waste collection containers. Problems — waste accumulation, cars are being parked in chaotic way. The wind blows debris and waste across the territory.

Target state

4.5.3 A detailed plan for the recreational paths, cycling polygons

Area

Rrecreational paths, cycling polygons

Condition / problems

An unmarked route/path that was popular on the Vovchynets hill has led to an unauthorized felling of trees. In addition, such route was traumatic. Forest managers complained of cyclists, and doctors have repeatedly testified to the traumatism of cyclists and children riding this route. In 2007, the route was marked for the first time and appropriate measures were taken to safeguard users. The total 2-way route of 25 kilometres was developed. The sign of the bicycle tourist route to Kozakova Dolyna in the Vovchynets Hill began with the final stop of trolleybus no. 3, through Vovchynets village and went all the way to Kozakova Dolyna. At the beginning of the route there was a board with a detailed description of the route, traffic scheme and map. All along the route, there were arrows on the trees that indicated the direction of traffic, as well as resting places. The final stop was Kozakova Valley, where a banner with a route and a rest area were placed. Due to this, the cycling route in the Vovchynets Hill has become civilized and gave the opportunity to ride not only children safely, but also to polish skills for cycling athletes and engage in extreme types of cycling. In 2018, city council has made an attempt to recover the route. 5 labelled and 4 environmental tables on the route installed. But these measures are not efficient now. Different tables/boards, routes disorganise users. Downhill cyclists created cycling polygons that are not marked. The route is not maintained, has some unauthorized dumps.

Target state

Renewed bike route that can be used for cycling and hiking with 30 informational and educational boards/signs installed on the entire length of the route. The area of the route — cleaned and maintained. Polygons renewed, modernized and safety measures realized. The route is highly promoted and is presented on the all information, tourists' web-sites, mobile apps etc. In next 5 years new routes designed and promoted for different categories of users, with different levels of difficulty well-organized marking system.




Figure 9- Map showing the planned location of space




Figure 10 – Sketch of bike recreational space




Figure 12 - Design proposal of 1st observation deck




Figure 14 - Example taken form Internet⁴




Figure 15- Sketch planned playground in the forest




Figure 16 - Map showing the planned location of space

There is a bus stop in the entrance in the Vovchynets village. Buses go from city centre (route no.34). Bus stop shelters have to be constructed and well-equipped.

Parking places now are not available. Drivers park the cars on any space and it is very chaotic and not good for village residents.

One of the major city roads ends near the entrance to the Vovchynets Hill (Vovchynetska Street). There is a strong need of continuation of the road across the Hill as it connects the city with our villages that due to the Decentralisation Form will be the part of Ivano-Frankivsk City United Territorial Unit. People use this area to drive to the work office, schools and kindergartens. In addition, there is a challenge with road construction as the Hill consists of limestock rocks. That's why this natural peculiarity should be taken into account.

Bus stop shelters should provide a place to sit, protection from weather, and a feeling of safety and security. People need to know when a bus will arrive and where it will go. This is especially important for people who are unfamiliar with the service, such as tourists. Schedule, route information, and a map should be located in or next to bus shelters but not so that the view of the

Parking space should be clearly defined and marked for the drivers. It should be connected to the road and does not preclude the entrance from residents' houses.

Road connecting Vovchynets village with Kolodiivka, Uzyn and Dobrovliany Villages should be constructed.




Figure 18- Sketch of road that need to be constructed

Condition / problems

Level of awareness on the Vovchynets Hill of the Ivano-Frankivsk city residents is rather low. People know that there is a Hill. But information of beautiful landscapes, Reserve Kozakova Valley, bike routes, and rich historical background is so limited.

According to the stories of the elderly inhabitants of the village Kolodiivka, Kozakova Valley has been known since 1648. At that time, on the picturesque site of the present Vovchynets, where two rivers of Bystrytsa converge, broke up the camp of the Cossacks of Vysochana. Immediately in 1945, liberation uprising was in the camp. Subsequently, in memory of the Cossacks, the Highlanders nicknamed the place the Cossack (in Ukrainian Kozak) Valley. Like the Khortytsia island in the Zaporizhiia region, an oak, which is more than 300 years old, is growing on the Kozakova Valley.

Target state

Promotion and information activities are conducted regularly. Level of population awareness increased. Nevertheless, the information should contain data of behavior in the urban and peri-urban forests. Also, the load of users on the area still should be monitored and controlled.




Figure 19 - bodies which will be responsible for the implementation of the plan during the URBforDAN project and after

6.2 **Revision of the plan**

The plan will be revised each 2 year by the Executive Committee of Ivano-Frankivsk City Council SE "Ivano-Frankivsk Forestry". The main responsible body for the control and monitoring of plan realization is the Executive Committee of Ivano-Frankivsk City Council.

Strategic and Operational parts of IMMPs will be joined together in one general IMMP.
