Additional Comments and Remarks

Meteorological data transfer

There is a problem with variable Air Temperature – filename which is on our server www.hidmet.gov.rs/korisnici/danube_his Dareffort_Srbija_27102020.txt refers to the date when it was created – but the value of Average temperature is for the day before 26.10.2020 – this value is from synop messages for 26.10.2020. $(T06+T12+T18*2)/4$ – now on site <http://dareffort.stasaapps.de/> it looks like that is value of Air temperature at time when it was uploaded - It should be variable t_a for the day before. Also there is a problem with variable daily precipitation – this value is from synop messages (in this case from 06 UTC day before 26.10.2020. till 06 UTC 27.10.2020.) total daily sum of precipitation – it supposed to be Precipitation total daily for day before. Meteorological time term for creation these two files is always 06 UTC.
