# **PART A**

# 1 Background

The Danube brings together the history of Europe. Humankind used the Danube from the very beginning as a promising place to live and to make business. Today, the Danube region is rich in cultural and natural heritage. The project Transdanube Travel Stories recognises tourism as important option to use this heritage and play an important role in regional development, especially in the remote regions of the Danube region. However, there is still little awareness of the Danube macroregion as a touristic area with rich natural and cultural heritage. European Cultural Routes and other networks are a first step towards transnational cooperation. They focus strongly on preservation, not offering innovative touristic products at the destinations or along trails, nor including sustainable mobility into their existing touristic products. Resultant, tourists rather drive from one site to the next by car, lacking deeper understanding for the region and appreciation of the sites.

The project main objective is to **support sustainable tourism development by applying innovative promotion concepts (new narratives) and existing mobility management tools**. The objective is supported by activities to position the sites' heritage within the wider context of the Danube macro-region with tools to experience this heritage building up a Danube memory (narratives). Mobility management includes ways to inform tourists about how to get to the region and around by other means than individual transport. Additionally to the development of institutions (product clubs, mobility centres) and instruments (mobility plans, narratives, apps etc.), the achievement of the main objective is supported by cooperation, capitalisation and promotion activities that present the Danube region as touristic area at international conferences.

The project is aiming at three specific objectives:

- 1. Employ innovative (more holistic) promotion approaches
- 2. Integrate sustainable mobility management measures/tools in route and destination management
- 3. Advance institutional capacity by sharing experience and capitalizing results among relevant stakeholders

# How to integrate sustainable mobility management measures/tools in route and destination management?

Mobility management includes ways to inform tourists about how to get to a specific destination and more around within the destination by other means than individual motorized transport.

Mobility management uses three important instruments:

1. Mobility Manager - take overall responsibility for developing and introducing mobility management



- 2. Mobility Centre is the operating unit at the urban/regional level
- 3. Mobility Plan most common instrument for site Mobility Management

The project is addressing these three instruments with different activities:

- 1. Mobility management trainings will provide relevant stakeholders with the necessary knowledge and skills to develop and introduce mobility management at the destination and trail level. The people trained will become **Mobility managers**
- 2. Mobility managers could be used to provide all relevant information to tourists and to coordinate the activities in the field of sustainable tourism mobility management in a region. They can do that in different positions and locations. One possibility would be to establish a **mobility centre** which can be approached by tourists in order to get the necessary information (either via the internet, via phone or in person). The guideline elaborated as well as the experiences gained when establishing 12 mobility centres in the course of the Transdanube.Pearls project can be used by the partners to establish a mobility centre at their destination.
- 3. Mobility plans or in the case of this project Sustainable Tourism Mobility Plans (STOMPs). These STOMPs will be the focus of this guideline.

# What is a Sustainable Tourism Mobility Plan (STOMP)?

STOMPs will provide the strategic background for improving mobility services on trail and destination level. The implementation of the necessary mobility management measures on route/network level will be supported by installing mobility managers. These persons will organise necessary mobility services and coordinate activities of different partners aiming the overall improvement of the sustainable transport system.

The STOMPs will therefore be the working programme for the mobility managers. Besides that, the STOMPs provide a valuable collection of information which can be used to design green travel products.

Building upon the 6 stories, for each of the 6 resultant trails a STOMP will be elaborated by the responsible project partners. These are:

- Tourism Board Linz (LT)
- West Pannon Regional and Economic Development (WP)
- Institute for Culture, Tourism and Sport Murska Sobota (IC)
- Croatian Association for Tourism and Rural Development "The Village Membership Club" (CA)
- Association for promoting tourism in Oradea and its region (OR)
- DANUBEPARKS Network (DP)

Once the approximate outline of the story is set and the destinations are chosen, the trail appears and will be assessed according to its accessibility by sustainable means of transport.



# 2 Definitions and specifications

# 2.1 Stories, trails and destinations

#### **Stories**

The project is expected to come up with **6 stories** in the Danube region.

- All stories follow the same standard and script (see Annex 1)
- Each **story** shall evolve along the trail and reflect in each destination. Therefore, the story shall include a specific **script** (see Annex 1)
- The stories shall include destinations out of the destination-pool (defined by the partners) that reflect the story.
- In every story that will be developed, the four meta-narratives ("change", "connect", "relax", "discover") should be represented. The destinations (chosen from the pool of destinations defined above) included derive from the story.

## Trail

We call the routes, that follow the stories "**TRAILS**", to differentiate from the cultural routes also involved in this project. (like the St. Martin of Tours-Route, the Route of emperors and kings, the Route of Jewish heritage, etc.).

- Each trail follows a different story.
- For each trail, the responsible partner has to elaborate a STOMP
- Each trail can be travelled along by sustainable means of transport.
- All included destinations and sites of a specific trail have to be accessible!
- Potentially, sustainable transport can be part of the story: train ride in an old Art Nouveau train carriage, pilgrimage by walking, cycling for experiencing nature, bus ride to encounter local people, ship to experience ancient-day travelling etc.

# **Destination**

A **destination** is a village or town where a point of interest selected to tell a specific part of a story is located. Destinations shall be chosen that can be reached in a consecutive way and which therefore define a certain trail. Destinations can be combined from different cultural routes and thematic backgrounds (cluster of themes) according to the story.

## **Point of interest**

A **point of interest** in this project is a location representing a specific touristic attraction within a destination (e.g. a museum, a nature park, an architectural highlight). It is this specific point of interest where a specific part of a story will be told by a guide/an app / experienced by the tourist. One destination normally offers a larger set of points of interest, but it might be only one or few of them



that are relevant for the story. It is these point(s) of interest that will be visited by the tourist. Besides the point of interest relevant for the story, a tourist might need/want to visit other points of interest e.g. a hotel, a restaurant or a railway station. This is why besides the point of interest level, the level of destination is relevant for the STOMPs.

# 2.2 (Sustainable) transport and mobility

The term **mobility** commonly describes the movability and the actual movement of people and goods. **Transport** related mobility takes into account that part of mobility which generates traffic. Mobility in this sense comprises the movement of people/goods from a location to another, creating traffic. For that people/goods are using different modes of transport including air, rail, road, water, cable, pipeline, and space.

We are focusing on the sustainable mobility of people – freight transport is NOT taken into account.

There are many definitions of the **sustainable transport**, and of the related terms sustainable transportation and **sustainable mobility**. The European Union Council of Ministers of Transport defines a sustainable transportation system as one that:

- Allows the basic access and development needs of individuals, companies and society to be met safely and in a manner consistent with human and ecosystem health and promotes equity within and between successive generations.
- Is Affordable, operates fairly and efficiently, offers a choice of transport mode, and supports a competitive economy, as well as balanced regional development.
- Limits emissions and waste within the planet's ability to absorb them, uses renewable resources
  at or below their rates of generation, and uses non-renewable resources at or below the rates of
  development of renewable substitutes, while minimizing the impact on the use of land and the
  generation of noise.

With the activities of our project we are focusing on energy efficiency, multimodal travel chains including train, bus, bike, hiking and shipping.

# 2.3 Sustainable tourism (mobility)

The world tourism organization defines sustainable tourism as:

"Tourism that takes full account of its current and future economic, social and environmental impacts, addressing the needs of visitors, the industry, the environment and host communities" Sustainable tourism should:

- Make optimal use of environmental resources that constitute a key element in tourism development, maintaining essential ecological processes and helping to conserve natural heritage and biodiversity.
- Respect the socio-cultural authenticity of host communities, conserve their built and living cultural heritage and traditional values, and contribute to inter-cultural understanding and tolerance.
- Ensure viable, long-term economic operations, providing socio-economic benefits to all stakeholders that are fairly distributed, incl. stable employment and income-earning opportunities and social services to host communities and contributing to poverty alleviation.<sup>2</sup>

As 50 % - 75 % of environmental impacts of tourism are caused by transport (air pollutants, noise, greenhouse gas emissions, land take, damage of landscape and villages)<sup>3</sup>, sustainable mobility in tourism is a very important component of sustainable tourism development. Sustainable tourism needs sustainable access and mobility: zero emissions, healthy and environmentally friendly, energy efficient and carbon neutral, comfortable and flexible from home door to hotel door

Following up on the project Transdanube and Transdanube.Pearls we continue to support the **common vision** signed by more than 70 stakeholders from the tourism and transport sector from the Danube region:

The common vision and aim is to develop a Danube region, which provides socially fair, economically viable, environmentally friendly and health promoting mobility and tourism for citizens and guests of the region by developing of climate friendly, low carbon and low-emission, multimodal and efficient transport systems and sustainable tourism services based on renewable energy sources, saving energy and resources, preserving natural and cultural heritage and taking care of the sensitive Danube ecosystems and landscapes while at the same time ensuring sustainable regional development and offering new chances for green economy and green jobs in the region. To this end we will strengthen our endeavors, dedicate resources and develop further our collaborations to promote the practical implementation of our common vision.



Based on these definitions and specifications the following principles need to be applied for the elaboration of the STOMPs:

- 1. The focus areas of the STOMPs are the trails including the transport nodes necessary to getting there and away. Each trail consists of a set of points of interest in selected destinations that reflect the story
- 2. The STOMP should include information about the possibilities to travel the respective trail by sustainable means of transport.
- 3. Sustainable means of transport (or sustainable mobility services) including train, bus, bike, hiking and shipping
- 4. STOMPs are targeting at tourism mobility. Therefore the information summarized in the STOMPs should especially take into account the requirements of tourists and how are they different to the requirements of inhabitants.
- 5. When assessing sustainable mobility services the whole touristic service chain will be taken into account





# **PART B**

# 3 Focus area

Trail #2 "Returning to the Last Danube" is one of six interconnected thematic routes within the Transdanube Travel Stories project. Each route travels a specific section of the Danube. Trail #2 focuses on the middle and lower part of the river with destinations in Croatia, Bulgaria and Romania. The destinations are also part of the DANUBEPARKS Network. DANUBEPARKS the Danube River Network of Protected Areas consists of 18 Protected Areas along the Danube. Nature Tourism and environmental education are main tasks of each Protected Area. Therefore, the STOMP includes all partner protected areas apart from Trail #2.

# 3.1 The story behind the trail

The river system of the Danube, despite substantial human interference, still preserves traces of intact, pure, ancient nature in certain sections, providing the last refuge for dozens of protected species. The Danube Protected Areas preserve this natural heritage and provide recreational areas and the opportunity to get in touch with nature.

The Danube's upper and middle sections attract visitors and those longing for active recreation with unrivalled natural treasures and invaluable habitats. It is enough to look around at the German source of the river where the streams Breg and Brigach meet near Donaueschingen, to find the magical slopes of the Black Forest and somewhat further to be attracted by the Danube Riparian Forest between Neuburg and Ingolstadt for some birdwatching.

Crossing the border towards Austria the dramatic Donauschlinge bend is there to be admired; to the south from Vienna Donau-Auen National Park offers the possibility to find out about the valuable floodplains protected with great enthusiasm, while in the Hungarian section there is Szigetköz famous for its islands, shoals and side-branches, the Danube-bend separating the masses of Börzsöny and Visegrádi-mountains, or Gemenc, the adventurous, mostly forest covered floodplain, allowing the visitor to submerge in the highly diverse realm of the river.

The true adventure, however, meant by a legendary, pristine wilderness unknown for many of us, follows only further ahead, in the lower Danube sections across the Hungarian-Croatian-Serbian border.

The enormous green oasis stretching along the middle river length section hides a true paradise for water birds and fishes, composed of highly variable vegetation including marshes, floodplain forests and wet meadows constantly interchanging along with flood dynamics in Béda-Karapancsa – Kopacki rit and Gornje Podunavlje. The immense monument of the Iron Gates, on the other hand, opens up a breath-taking memento for visitors about the continuously competing forces of man versus nature, and thus, carries a dubious message.

# 3.2 The trail

With 2,857 km in length, the Danube is the second-longest river in Europe (after the Volga river) and the longest river in the European Union. Its basin area covers more than 800,000 km2 or 10% of Europe's surface.

The Danube is the only eastbound river in Europe. It originates in Germany's Black Forest as the much smaller Brigach and Breg rivers join in the town of Donaueschingen. The Danube then flows eastward, passing through several Central and Eastern European capitals before emptying into the Black Sea via the Danube Delta in Romania and Ukraine.


The Danube basin includes the territories of 19 countries and is home to more than 83 million people with a wide range of cultures, languages, and historical backgrounds. It is the single most international river in the world, affecting more nations than any other river.

It crosses 10 countries: Germany, Austria, Slovakia, Hungary, Croatia, Serbia, Bulgaria, Romania, Moldova, and Ukraine. So, transport along the river not only provides jobs but provides a greener alternative to roads.

The European Commission recognizes the Danube as the "most important non-oceanic body of water in Europe" and a "future central axis for the European Union".

Due to its large area and very diverse habitats, the Danube River is one of the most important natural treasures of Europe and a backbone for biodiversity conservation. Over 2.000 plant and 5.000 animal species live in or by the waters of the Danube.

When the River transforms into the Danube Delta it becomes one of the world's largest wetlands, featuring 30 different types of ecosystems. With over 9,500 flora & fauna species, spreading on over 5,050 km2 of marshes, canals, reed islets, and lakes, Danube Delta is the third place in the world regarding biodiversity. Only The Great Barrier Reef in Australia and Galapagos Island have greater biodiversity.



DANUBEPARKS is the Network of Protected Areas along the Danube River, which currently consists of 18 Protected Areas from 9 Danube countries, all hotspots for biodiversity.



# The Trail Returning to the Last Danube

The trail tells the story of the middle and lower part of the Danube by connecting Nature and Man.



The true adventure, meant by a legendary, pristine wilderness unknown for many of us, can be found in the lower Danube sections across the Hungarian-Croatian-Serbian border.



The enormous green oasis stretching along the middle river length section hides a true paradise for water birds and fishes, composed of highly variable vegetation including marshes, floodplain forests and wet meadows constantly interchanging along with flood dynamics in Béda-Karapancsa – Kopacki rit and Gornje Podunavlje. The immense monument of the Iron Gates, on the other hand, opens up a breath-taking memento for visitors about the continuously competing forces of man versus nature, and thus, carries a dubious message. Persina, with an island realm hardly explored by tourists, and the Danube Delta, the majestic finale of the river's nearly 3,000 km long journey, with a nature show going on in its 21-thousandhectare fantastic wetland paradise both amaze the visitor with the astonishing richness and diversity, vivid but globally disappearing essence of Europe's last, almost untouched wilderness. The trail, its destinations and points of interest are presented more detailed under 4.3 How to move within a destination.

## **Destination 1: Danube Delta**

**Background Information:** At the end of a course of over 2,840 kilometres, collecting the water from a vast hydrological basin that exceeds 8% of the area of Europe, the Danube has built one of the most beautiful deltas in Europe. The Danube Delta is one of the biggest wetlands in the world. A living museum of biodiversity, with 30 types of ecosystems, the Danube Delta is a natural genetic bank with inestimable value for natural world heritage. Among the water formations in the delta are running waters, fresh still waters like big lakes and lakes inside polders, isolated lakes with still salted or brackish waters, coastal lagoons connected to the sea and marine coastal areas with semi-closed gulfs. Its wetlands include the largest area of compact reed beds on the planet. The delta's diverse landscapes range from floating islands, willow formations and meadows on flooded banks, river plains, oak forests, shrubs, grassy areas, steppe meadows, meadows on marine levees, shifting sand dunes with little vegetation, coastal belts and beaches as well as agricultural polders, to forest polders and poplar plantations on river banks. Access for tourists in the Danube Delta Biosphere Reserve is allowed based on entrance permits. Entering in the strictly protected areas is forbidden.

## **Points of interest:**

Danube Delta can be entered from Tulcea, Mahmudia, Murighiol. From there points of interests are Mila 23, Crisan, Sulina, Caraorman and St. George.

# **Destination 2: Lower Prut Nature Reserve**

## **Background information:**

One of the natural wonders of the Republic of Moldova, the Lower Prut Nature Reserve is a true paradise for diverse bird, fish and plant species, protecting the area surrounding Lake Beleu and the Prut River.

Located in the south of the country, this biosphere reserve encompasses the Prut River and floodplain lakes. Two-thirds of the surface of the area are occupied by Lake Beleu. A wetland area extends along the Prut River, covering a mosaic of water, meadow and forest ecosystems. The main economic activity is agriculture, which provides 90% of the inhabitant's income.

**Points of interest**: the educational info centre in Slobozia Mare, the Eco-Village Valeni Tara Bitlanilor, Cariera Fetesti, La Castel, Padurea Domneasca, Beleu Lake



#### **Destination 3: Rusenski Lom Nature Park**

# **Background information:**

Rusenski Lom Nature Park is situated in Northeast Bulgaria, along the canyon shaped valley of Rusenski Lom River – the last right tributary of the Danube River. Its area is 3,408 hectares. From each altitude in Rusenski Lom Nature Park amazing views burst. Within the endless river valley curves are waved as well as forests, the wild beauty of rock peaks and the old castles and settlements.

Rusenski Lom Nature Park flora numbers 902 species of higher plants. 13 species of Orchid family are fixed in the Park.

Birds amount to a total of 192 species, 174 of them under protection – this is the reason why the Lom river valley has been announced to be a significant ornithological spot; especially interesting for scientists are the rock dwelling species: Egyptian vulture, Black stork, Ruddy shelduck, White tailed Buteo, and owls.

Along the valley 70 out of totally 90 species of Bulgaria's mammals can be found; 26 of them are various species of bats. The high percentage of rare and protected species of mammals is due to the diversity of living conditions and habitats and proves the exclusive conservational significance of the Park for their preservation.

**Points of interest:** Lomovete Special Protection Area, Ivanovo rock hewn churches - near the village of Ivanovo; Medieval fortress of Cherven - near the village of Cherven; The Large cave near the village of Pisanets.

# **Destination 4: Persina Nature Park**

#### **Background information:**

The only nature park in Bulgaria situated at the Danube River bank is the Persina Nature Park. It is unique as it consists of numerous islands in their natural state, formed in two big island groups Belene Island Complex and Nikopol's Island group. It is a paradise for numerous colonies of waterfowl, a nesting place for the Mute swans, White tailed eagles and Dalmatian pelicans, an autumn gathering of the Black stork. Some of the islands reach lengths of up to 15 kilometres. The group of islands Belene Island Complex was proclaimed a Ramsar site in 2002, the biggest one in Bulgaria with 18,330 hectares.

The most tremendous wealth of the park is found in the natural flooded forests of willows and poplars and the inland marshes along the Danube. For the protection of these habitats several protected areas have been designated, such as the Kitka and Milka Reserves, both embracing islands of the same name, the Persinski blata Managed Reserve and the Persina-iztok Protected Area, located on the eastern part of Persin island, the Kaikusha Protected Area, a former marsh at the park's south Boundary and the Plavala Protected Area near the town of Nikopol.

#### **Points of interest:**

Persina Nature Park Visitor center Kaykusha Protected Area



# **Destination 5: Iron Gates Natural Park and Djerdap National Park**

**Background Information**: The Iron Gates are the most amazing, most picturesque section of the Lower Danube. At the same time, they are the most obvious evidence of the infinite clash of powers that has been going on between water and rock in order for water to be able to carve a way for itself. With austere majesty and steep walls, towering cliffs line the riverbed on both sides, involuntarily making one bow before this majestic masterpiece of the creator nature.

The immense monument of the Iron Gates, opens up a breath-taking memento for visitors about the continuously competing forces of man versus nature. The panorama is magnificent, overwhelming, an immense, a heroic landscape, unique among the navigable rivers of Europe.

The Iron Gates Natural Park is located at the spot where several major Carpathian and Danube regions meet, thus forming a spectacular landscape rich in biodiversity. This Protected Area is a vital link for habitat corridors in South East Europe.

# **Destination 6: Kopacki rit Nature Park**

**Background information:** The Kopacki rit Natural Park is an important waterfowl habitat and one of the most important floodplains in the whole of Europe as well as an inner delta with distinct features. The area is the most important spawning place for fish in the Central European part of the Danube River.

The appearance of the whole area depends on regular floods and the landscape changes its shape and function according to the amount of floodwater. Kopaèko Lake is the largest, while Sakadaš is the deepest lake in the area. The lakes are interconnected with rivers through a network of natural channels. Extensive reedbeds, backwaters, ponds, lakes and channels, forests, marsh pastures in blossom and wet grasslands provide ideal conditions for many species.

# **Destination 7: Gornje Podunavlje Special Nature Reserve**

# **Background information:**

Gornje Podunavlje is the largest floodplain area in Serbia. Together with Kopacki rit in Croatia and the Danube-Drava National Park in Hungary, the reserve forms a 70,000-hectare Central Danube Floodplain Area. It comprises two big marshes along the left bank of the Danube River - the Monostor and Apatin marsh and is a truly representative floodplain wetland.



River and flooding dynamics create an extraordinary mosaic in the beautiful landscape. Natural forests are a large part of the reserve that is well preserved and very attractive for wildlife. With its occasionally flooded wet meadows, numerous oxbow lakes and swamps which were once widespread in the Danube wetlands, it is one of the best preserved wetlands in the Danube River Basin. In the highest parts of Gornje Podunavlje, far from the water level, ancient alkaline grasslands can be found.

#### **Destination 8: Duna-Dráva National Park**

**Background information:** The Danube-Dráva National Park is an alluvial plain divided by a flood prevention dyke. Before the regulations the river followed a course with wide bends which gradually cut themselves off and created a succession of dead branches and oxbows along the main bed. Areas in between the side-branch and the main bed have developed into extensive islands, some of them 15 kilometres long. Characteristic small canals have formed naturally in the spectacular high banks, through which water bodies, dead branches and depressions are interconnected with each other. Acidic sandy grasslands with isolated bogs in between sandy ridges follow gully-like erosive valleys cut deeply in the low hilly region of the Zákány-Őrtilos Hills.

# **Destination 9: Duna-Ipoly National Park**

The Danube-Ipoly National Park was the ninth national park founded in Hungary, and is perhaps the most diversified of all of them. Situated between the Danube and the Ipoly Rivers, it keeps the Pilis-Visegrád Hills, Börzsöny, Ipoly Valley and the Danubian part of the Great Plain in one unit and is committed to preserving the natural values of the highland woods and river habitats.

The national park includes several impressive hills, such as the Csóványos (938 m), the Nagy-Hideg Hill (864 m), the Pilis Peak (756 m) and the Dobogó-ký (699 m). The rock-bed of the Pilis Hills stretching from Esztergom to Budapest is made up of limestone and dolomite. Because of the basic characteristics of the rock formation, the hills are exceptionally rich in caves. Most of the 334 caves of the national park can be found in the Pilis Hills. Other areas of importance include the Pilis Biosphere Reserve, the Ipoly Valley Ramsarian Area, the Pilis Hill-side Forest Reserve, the Preacher's Podium Forest Reserve and the Pogány-Rózsási Forest Reserve.

# Destination 10: Szigetköz Landscape Protection Area, Fertö-Hánsag National Park



**Background information:** The Fertö-Hanság National Park Directorate manages protected areas from the slopes of the Bakony to the Sopron Mountains, from the Danube to the meadows and oak forests in the Rábaköz region. The Szigetköz Landscape Protection Area covers about 500 small islands and hundreds of shallows, islets and inner lakes.

# **Destination 11: Dunajské Luhy Protected Landscape Area**

**Background information:** The Dunajské luhy Protected Landscape Area consists of five separate parts. This unique area, situated on a natural levee of the Danube, is one of the largest inland river deltas in Europe.

The system of natural levees, depressions and the accumulation of a dense network of river branches are the most significant characteristic of the Dunajské luhy Protected Landscape Area. But the area also includes floodplain forests, wetlands, meadows and water bodies, such as lakes, oxbow lakes, ponds and streams.

#### **Points of interest:**

#### Island Veľký Lél

Veľkolélsky ostrov Island or Nagyléli sziget is known on both sides of the Danube river as one of the last large Danube islands covering more than 250 hectares of land. It is managed by BROZ, an NGO for Nature conservation who offers camps and excursions for visitors.

# **Destination 12: Záhorie Protected Landscape Area**

**Background information:** The Záhorie Protected Landscape Area is the first proclaimed lowland protected landscape area in Slovakia. Three types of landscape structures create a colourful and dynamic periodically flooded environment with adequate living conditions for a wide range of plant and animal species. The area is well preserved because of its 40-year function as a border between Western Europe and the Eastern Bloc. The area is part of an important route for migratory birds.

The northeastern part of the area is influenced by wind processes associated with the transfer of sand. Sand-hills, wind corrugated sheets, rounded sifts and crescentic dunes are the main landscape types here. The western part consists of river terraces and wide river alluvium as well as floodplain alluvial meadows. The meadows are also harmoniously distributed in the vicinity of swamp forests, densely interlaced by a network of old branches, river lakes and seasonal wetlands spread in the riparian forest zones and floodplains.

# **Destination 13: Donau-Auen National Park**



**Background information:** The Donau-Auen National Park preserves the last great floodplain landscape in Central Europe on an area of more than 9,600 hectares. With its foundation in 1996, this nature jewel was placed under international protection sustainably. Since then, nature has been able to develop here free from economic constraints.

# **Destination 14: Wachau Protected Landscape Area**

**Background information:** The Wachau is a stretch of the Danube Valley between Melk and Krems. The Wachau region is famous for its picturesque landscapes, excellent wines, and flowering apricot trees.

In one of the last free-flowing Danube sections on the Upper Danube, conservation actions are focused on river dynamics and restoration.

The Wachau has become part of UNESCO's World Heritage List in 2000. It preserves in an intact and visible form many traces - in terms of architecture (monasteries, castles, ruins), urban design (towns and villages), and agricultural use.

The clearing of the natural forest by local peoples began in the Neolithic period. Although radical changes in the landscape did not take place until around 800 AD, when the Bavarian and Salzburg monasteries began to cultivate the slopes of the Wachau, creating the present-day landscape pattern of vine terraces.

# **Destination 15: Narrow Valley of the Danube in Passau district**

# **Background information:**

On its 2,850-km journey through Europe, the Danube River connects very different landscapes. While it flows from Regensburg to Hofkirchen in broad arcs through the wide valley, it crosses the picturesque narrow valley between Hofkirchen in the Passau district to Aschach in Upper Austria and intersects the southern foothills of the Bavarian and Bohemian Forests. The resulting steep valley slopes are called "Leiten".

In the Protected Areas along the Danube between Hofkirchen in Bavaria and Aschach in Upper Austria, there are large semi-natural gorge and hillside mixed forests. These occupy an outstanding position within the cultural landscape of Central Europe, as no other comparable areas have been preserved within the entire European area of the Danube.

Due to the shape of the terrain, hot, dry rock areas lie side by side on the steep slopes with cool-moist valleys with springs, streams and rivulets. Here silicate rock and base-rich rock meet – extraordinary for the Bavarian Forest – creating an exceptional diversity of habitats. These conditions result in high biodiversity, which is expressed in a large number of species of plants, animals and mushrooms that make their home here. In



addition, the area's location on the Danube and proximity to the Inn and Ilz Rivers contribute to the occurrence of unique species and communities.

# **Background information:**

The entire region has preserved its special character as a dense riparian forest because of the protection by the former Dukes of Bavaria as a hunting area, where nature meets history.

The great importance of the Central Sava Floodplains is related to the rarity of natural floodplain ecological systems in Europe, as a result of the drainage and regulation of the great rivers, particularly in their central courses.

This port town once bustled with traders from Europe and the Middle East, adventurers and sea pirates. The town served as headquarters for the European Danube Commission during the 19th century when the Danube was turned into a waterway suitable for commercial shipping. This huge project attracted workers from all over Europe, and the Anglican, Catholic, Protestant, Orthodox, Muslim and Jewish tombstones in Sulina's cemetery bear witness to this former international community.




# 4 Status quo analysis of sustainable travel options along the trails and within the destinations

The following chapter provides information about sustainable transport services for each destination. Each Protected Area of the DANUBEPARKS network is a destination. The analysis shows how the visitors centres can be reached from major cities. The trail "Returning to the Last Danube" is a section of the whole "DANUBEPARKS-trail" and analysed from Chapter 4.3 where we focus on how to move within destinations.

The information in the analysis was gathered through a questionnaire send out to all DANUBEPARKS partners, by a desk research and also in the course of an expert workshop.

The map of the DANUBEPARKS Network shows the Protected Areas in each country. The destinations can be reached from various major cities along the Danube. We are following the stream of the Danube River starting at km 0 in the Danube Delta.



The Danube connects not only our Protected Areas it also connects 10 countries with major cities that function as starting points to reach our Protected Areas and the Points of interests close to them. In this analysis we connected the next biggest cities close to the Protected Area visitor centres by public transport. We assume that from each bigger city other big cities and countries can be reached by public transport.

## **5 SWOT Analysis**

## 5.1 Sustainable mobility services along the trail

	Positive	Negative
Internal characteristics	The trail "Return to the Last Danube" and the DANUBEPARKS Network consist of the most valuable natural sites along the Danube which provide a great experience for visitors. Some of the visitor centers are well connected with the major cities and provide very good information on their website.	The protected areas and visitor centers are located in remote areas and not easy to reach by public transport. For most visitor centers there is a connection but the trip is quite time consuming. The encouragement to use public transport on the websites of the Protected Areas is low.
External characteristics	Climate change and also the pandemic bring Nature and Nature protection more in focus of decision makers. The current interest in Nature protection can be used for future projects on the topic of environmental education and awareness raising. In the course of these projects the infrastructure for sustainable mobility services can be improved.	Public transport services are not used by visitors enough and therefore cannot be funded in the long-term. Some visitor centers don't have a public transport connection and the funding to improve the situation is difficult as the number of travelers interested to use public transport services is not that high. Even if the public transport service is in place the frequency of busses or trains remains low.



## 5.2 Information services on sustainable mobility options along the trail

	Positive	Negative
Internal characteristics	Some of the Protected Areas provide travel information with public transport providers on their website and also encourage visitors to use them.	A lot of Protected Areas do not provide any travel information on their website. It is even more difficult to find information in English.
External characteristics	There are some travel portals like Rome2Rio which help a lot with planning trips. Also some bus and train service providers have English websites that help planning trips.	In most of the areas along the trail "Return to the Last Danube" no information on public transport providers can be found in English on local websites. The train and bus schedules are not very frequent. Travelling takes a lot of time. The part from the last bigger village to the Protected Area very often can only be travelled by taxi and even that sometimes is not possible.



## 6 Recommendations for improvement

The basis of the recommendations are the findings of the questionnaire send out to all DANUBEPARKS partners and the desk research. The recommendations have been discussed in the course of the expert workshop.

Description	The status of sustainable mobility services within the DANUBEPARKS Network
	and the trail "Return to the Last Danube" varies a lot. Still improvement should
	be possible everywhere. Therefore, overall improvements are suggested:
	- Travel information on sustainable mobility services on websites of the visitor
	centre in local language and in English.

- For Protected Areas which already provide the travel information, the encouragement to use public transport could be improved. (e.g. Position of the information on the website, incentives for visitors that arrive by public transport, support of climate change projects).
- Adaption of excursion programmes to the time schedule of public transport services.
- Cooperation with public transport service providers.
- Travel information to Protected Areas on DANUBEPARKS Website.

## Responsible institution

Each protected area is responsible for the implementation of travel information on their websites. But the DANUBEPARKS Association should support their members in their communication activities and also provide the information on the DANUBEPARKS Website.

The DANUBEPARKS Association should ask their members if any support for updating the website with the travel information is needed. Be in touch with communication officers of each member and make sure that the information is accurate. Also provide information to foreign visitors on the DANUBEPARKS Website.

## Horizon for implementation

The basic information can be implemented until middle of 2022. But further discussions should be made within the network how travel information could be provided in a user-friendly way and if joint communication activities should be implemented through a project. A project on nature tourism communication could be developed until end of 2022 and maybe start somewhere in 2023. Joint website development and corporate design could be finalised in 2024.



# 6.1 Recommendations for each destination of the DANUBEPARKS Network including the trail "Return to the Last Danube"

#### 6.2 General recommendations for the whole trail

#### Increase communication of sustainable mobility services:

- Travel information needs to be included on the websites of visitor centres and the DANUBEPARKS Association.
- If the travel information is on the website, it needs to be presented before travelling by car to encourage visitors to use public transport.
- If the public transport services are not well established, cooperation's with local taxi providers should be established and communicated.
- Communication campaigns for sustainable mobility should be created maybe on Danube-wide scale with the DANUBEPARKS association. E.g.: Week of sustainability free entry to the visitor centre if travelling by sustainable means of transport.
- Cooperation with public transport service providers especially for events.
- Adaption of visitor programme to schedule of public transport.
- Climate change and sustainable mobility reflected in communication activities. (e.g.: Climate change projects, tree planting activities, waste collection activities, volunteers days.)



## 7 Good practice collection


In the course of the questionnaire filled out by experts of the different areas and the expert workshop only the Amazon of Europe Bike trail and Lena Project, both funded through the Danube Transnational Programme were mentioned. The topic of sustainable mobility is not addressed in projects of our Protected Areas. In the course of the survey and through the expert workshop, awareness on the topic could be raised and the discussion for future projects on sustainable mobility has been started. As a lot of our Protected Area visitor centres can not be reached by public transport and the recommendation is to travel the last part to by taxi another best practice for involving local taxi service providers would be "IST mobil".

As an innovative hybrid of classic public transport and cab services, the ISTmobil micro public transport mobility solution combines the advantages of both systems and offers an additional, sustainable mobility service away from the private car. ISTmobil, unlike other commercial providers, does not have its own fleet of vehicles. Instead, transportation services are provided locally by regional cab, rental car or bus companies. In this way, existing mobility services are networked within a region, a demand-oriented mobility supply is ensured, and the regional economy is strengthened.

Through the online platform local taxi providers are connected with customers. The taxis can only be booked if there is no public transport service available at the same time. The participating regions and municipalities receive different taxi stops from where the trip starts or ends. The costs of the trip are cheaper than a normal trip by taxi. The more people are travelling, the cheaper it gets.

46. Comment: is there any information or comment you would like to share which has not been addressed yet?

- No.
- Not yet, what is missing here is a better communication in between different parts like the Government, locals. Investments for the infrastructure ( no roads) etc.
- Genaral comment: besides the National Park several other protected areas belong to Danube-Ipoly National Park Directorate as well: 8 Landscape Protection Areas and 36 Nature Reserves and "ex lege" protected nature assets (e.g.: caves), 1 Europa Diploma site, 1 Biosphere Reserve. The operation area of the Directorate covers 3 counties (Pest, Fejér, and Komárom-Esztergom County), 1 354 903 hectares. The options to reach the different sites (locations) are quite different.
- Point 8: we gave the number of registered visitors of the year 2019. In year 2020 we had far more less visitors (100 900) beacause of Covid19. There are lots of visitors in our operational area who are not registered and we have no data about them.
- Point 38: we need more information about mobility centre and deatails about the proposed project to make a statement.
- We are putting efforts into attracting visitors to Gornje Podunavlje and make it as tourism destination visible.
- In my opinion there is a strict regulation preventing cars from entering tracks (e.g. forest tracks) in protected areas in general, what is good in one hand, but on the other hand, there is a demand from public to access these areas and that question has no good solutions so far.
- There is a great potential of protected areas around capital Bratislava for recreation, most of it is realised in Malé Karpaty and Záhorie Protected Landscape Areas, facilities for recreation in Dunajské luhy are not well developed, also promotion is missing. There are great possibilities of cross-border cooperation in that field, still very little utilised.
- I think public transport with transportation of own bikes is the challenge. People have often expensive bikes which they want to use and have less interest in hiring middle-quality bikes.
