

Introduction

The international hybrid event organised by BRAIT was attended by national and local government representatives and policy officials, members of national and transnational organisations, clusters, NGOs, and representatives of the private sector. The majority of the participants and speakers joined online but there were also quite a few who managed to join the conference in person in Sofia, Bulgaria.

At the first day of the conference various internationally recognised experts presented on the topics of Policy Framework, Bioeconomisation, and Participative Governance. The second day of the conference was more interactive and gave participants the opportunity to discuss their findings and conclusions from the previous day in three thematic breakout sessions based on the aforementioned topics.

The conference managed to involve the key stakeholders of the GoDabuBio project and provided them with an excellent opportunity to learn more about the concept of Circular Bioeconomy and how it can be used as a tool for fostering regional development in the Danube region. In addition, the conference paved the way for interdisciplinary cooperation between different policy areas and sectors of production in order to address demographic change in a participative, multi-governance way.
