Introduction

On the 18th and 19th of October, 2022 the Final conference of DanubePeerChain project was organized in the frame of the Sustainability Forum "Southeast Europe & Danube Region".

<u>Sustainability Forum</u> aimed to strengthen cooperation between the countries of South-East Europe and the Danube Region for the achievement of the global objectives of sustainable development through a multidisciplinary and comprehensive approach in line with the SEE 2030 Strategy and the UN 2030 Agenda.

The main sustainable development goals promoted at the event were Decent work and economic growth-8, Industry, innovation and infrastructure-9, and Partnerships to achieve the goals-17.

Concept and development

The Sustainability Forum was organized by the Department for Sustainable Development of the Romanian Government in cooperation with other stakeholders, such as, the Association of Business Incubators from Romania, the Romanian Cluster Association, The Institute of Corporate Governance and Sustainability-CORP, the university "Alexandru Ioan Cuza" from Iaşi, SC Arhipelago SRL, North-East Regional Development Agency, Imago-Mol Cluster, BioNest Cluster, Enterprise Europe Network regional representatives, Technopolis Scientific and Technological Park.

The forum theme encompassed several aspects ranging from the role of clusters in generating green, digital, and resilient value chains, challenges faced by the labour force, bio-based business models, ecological agriculture, sustainable communities up to precision medicine.

The Sustainability Forum was an excellent opportunity to exchange best practices and experiences gathered across several European cooperation projects such as DTP DanubePeerChains, DTP GoDanuBio, Interreg Europe InnoIndustry, and COSME MedicNest.

The final conference of the DanubePeerChains, organized within Sustainability Forum, was realized by the Romanian Cluster Association in collaboration with the European Clusters Alliance and the European Cluster Collaboration Platform.



The final conference DanubePeerChains project is made up of the presentation of the results of the project in the first day of the forum and the workshop "Towards green, digital, and resilient bio-economy value chains. The Labour Force Perspective", in the second day of the forum.

The results of the DanubePeerChains project were presented as follow:

-on October 18th, 2022 at panel discussions" Best Practice Exchange Session", "Good practices from the Interreg DTP project DanubePeerChains" presented by ConPlusUltra project partner. -on October 19th,2022, a hybrid workshop with the main topic "Towards green, digital and resilient bio-economy value chains. The Labour Force Perspective", dedicated to challenges in the labor market with a special emphasis on existing value chains.

The workshop "Towards green, digital and resilient bio-economy value chains. The Labour Force Perspective" started with the welcome speach of the Mr. Terente Ciui, Secretary of State, Ministry of Economy, Romania. Then, Mr. Antonio Novo, the president of European Cluster Alliance presented the role of clusters as drivers of industrial ecosystems.

The workshop continued with the presentation of the Romanian National R&D Labour Institute representative, focused on the subject of bio-economy as a solution for value chain disruptions. Then the German Cluster Mechatronics & Automation at Bayern Innovative' representative shared their examples and practices. Another subject "Digital transition and sustainability in Slovenian VET institution" was presented by Šolski center Škofja Loka' speaker .

The representative of Astrico Nord–Est Textile Cluster, Romania presented the topic skilling, upskilling and re-skilling challenges of workforce in textile industry.

The presentations were followed by discussions and exchanges of ideas with the audience.

Impact and conclusions

The forum was well attended with representatives from over 12 countries including Germany, Hungary, the Republic of Moldova, Serbia, Turkey, Greece, Albania, Montenegro, Austria, Slovenia, and Spain: national public authority, regional public authority, local authority, business support organizations, university and research institutes, SMEs, and NGOs as follows:

-120 participants in the first day of the forum;

65 participants of which 23 online and 42 in-person in Iasi, at the workshop in the second day of the forum.

This event was distributed on the social pages of the organizers and partners and also on Facebook.

The first day of the forum was live on facebook and had 1400 viewers.

The Final Conference of DanubePeerChains emphasised once again the role of clusters in triggering innovative processes at regional level and marked an important milestone in the integration of Moldavian clusters - strongly represented at the event into the wider Romanian and European cluster family.



A key takeaway is that the sustainable development of SMEs and clusters and the growth of their international competitiveness must be the result of the development and application of new technologies (e.g. digitalisation of SMEs and digital skilling of workforce).
