## **Erasmus | Quick Facts**

- Established in **1987** with 11 European countries participating
- Financed through European Community funds in some countries supported by national co-funding
- Austria: strong commitment on political level to enhance HE cooperation & academic (credit) mobility of staff and students
- Erasmus+ since 2014 combining Education, Youth & Sports
- 2017: more than 4,000 HEI in 33 European countries
   → 70 participating higher education institutions in Austria

#### **Erasmus+ aims at**

- supporting internationalisation and modernisation of (higher) education in Europe and beyond
- promoting mobility among students and staff in order to enhance the professional & institutional profiles
- enhancing quality & attractiveness of Higher Education
- opening global academic cooperation
   → from "third countries" to "partner countries"
- supporting mutual learning and creating networks
- facilitating **access** to (higher) education  $\rightarrow$  social dimension

### **Actions available for Cooperation**

- **Erasmus+ Mobility Projects** in all sectors
  - organised mobility schemes (exchange, training) for schools or AE
  - mobility for pupils (traineeships), students (credit mobility) and staff
  - within Programme Countries; with Partner Countries only in HE

#### Strategic Partnerships in all sectors

- for *innovation* or for *exchange of good practice*
- Key Action 2 **Knowledge Alliances** in Higher Education only **University – Business Cooperation**
- **Capacity Building in Higher Education** 
  - targeted focus on partner countries' needs

### Strategic Partnerships Horizontal priorities

**Strategic partnerships** are to strengthen the development, the transfer and/or the implementation of innovation in education, contributing towards high quality learning, teaching and training as well as institutional modernisation and social innovation.

- Development of innovative approaches
- Promoting European key competences such as language skills, entrepreneurship, IT skills etc.
- Contributing towards employability through strengthening of labour market relevant content
- Enhancing the access, participation and performance of disadvantaged learners and facilitating their transitions
- Promoting equal opportunities & inclusion of disadvantaged groups



### Erasmus+ Strategic Partnerships

## **Possible objectives of a project**

- Modernisation in education (all sectors)
  - development of new curricula, modules or joint degrees
  - specific training programmes and platforms
  - new teaching methods and materials
  - development of Open Educational Ressources (OER)
  - improving the labour market relevance
- Development / implementation of the recognition of already acquired education (= recognition of prior learning, RPL)
- Integration of refugees, asylum seekers and migrants
- Development / adaptation of specific offers for people with disabilities, chronic diseases or disadvantaged groups



#### Erasmus+ Strategic Partnerships

## Partnership

- At least **3 organisations** from ≥ 3 programme countries
- Involvement of E+ partner countries if clear added value

## **Formal conditions**

- Project Duration: **1 3 years**
- Funding: max 150,000 Euro per year
- Decentral application procedure (i.e. National Agencies in programme countries )
- Application deadline: **February 2018** one annual date


#### Erasmus+ in Higher Education Knowledge Alliances



### **Knowledge Alliances**

are structured transnational and target-oriented cooperation projects between higher education and the business sector aiming at:

- Innovation in Higher Education and the World of Work
- Sustainability of cooperation between higher education institutions (HEI) and enterprises / companies
- Impact beyond the project lifetime



### Erasmus+ in Higher Education Knowledge Alliances



#### **Projects must aim at**

- Boosting innovation in higher education, business and in the broader socio-economic environment
  - Innovative learning and teaching methods
  - Solutions for challenging issues, product and process innovation
- **Developing entrepreneurial mind-set** and competences
  - Entrepreneurship education in any discipline
  - Schemes of transversal skills learning to strengthen employability, creativity and new professionals paths
- Exchange of knowledge between HE and enterprises
  - Activities in companies which are embedded in the curriculum
  - Involvement of company staff into teaching and research



### Erasmus+ in Higher Education Knowledge Alliances

## Partnership

- At least **6 organisations** from ≥ 3 programme countries
- Min two Higher Education Institutions and two Business Partner
- Additional non-university partners are an asset
- Involvement of partner countries if clear added value

## **Formal conditions**

- Project Duration: 2 3 years
- Funding: **700,000 1m Euro** per project
- Central application procedure (EACEA Brussels)
- Application deadline: **February 2018** one annual date

### Erasmus+ Capacity Building in HE Objectives of the Action



## Capacity Building in Higher Education aims at

- improving the quality of higher education in partner countries and enhance its relevance for the labour market and society
- improving the level of competences and skills in HEIs by developing new and innovative education programmes
- enhancing management, governance and innovation capacities, as well as the internationalisation of HEIs
- increasing the capacities of national authorities to modernise their HE systems, by supporting to the definition, implementation and monitoring of reform policies
- fostering regional cooperation across different regions of the world through joint initiatives, sharing of good practices and cooperation



## Erasmus+ Capacity Building in HE Project Types



## Two main project types

- Joint Projects (focus on the *institutional* level)
  - development, modernisation and implementation of new curricula, teaching methods or materials;
  - stimulation of quality assurance culture(s);
  - modernisation of the management and governance of HE institutions.
- Structural Projects (focus on HE systems level)
   relevant Ministry of every Partner Country to be involved
  - development and reform of national HE structures;
  - governance, qualification systems, quality assurance, accreditation;
  - enhancing links between higher education and society.

### Erasmus+ Capacity Building in HE Practical Aspects of a Project

## Partnership

- At least 3 HEI from 3 **Programme Countries**
- Partner Countries: same amount or more HEI at least two universities from each Partner Country
- Structural Projects: relevant authority of partner country/-ies

## **Formal Conditions**

- Priorities of partner country/-ies or region to be respected
   List of the priorities on the website of the Executive Agency (EACEA)
- Project Duration: 2 or 3 years
- Funding: **500,000 1m Euro** per project
- Central application procedure (EACEA Brussels)
- Application deadline: **February 2018** one annual date

#### **Important to all Actions**

- Clear focus on needs and priorities
  - Consistent needs justification in a wider setting
     EU Strategy for the Danube Region leads to perfect synergies
  - European, regional and/or thematic priorities to be followed

#### Solid partnership

- targeted focus on partner countries' needs
- Involvement of non-university actors always an asset (authorities, companies, business, NGOs, students associations etc.)
- Comprehensive dissemination strategy
  - from first day of the project
  - sustainability ≠ website & folders


